Borough Council Reorganizes

The Borough Council held its 2013 reorganization meeting on January 7. Re-elected Council members Tom Curry (previously elected in 2008) and Michael Ticktin (previously elected in 1973) were sworn in. Beginning her first full year on the Council was Councilwoman Michelle Hermelee, who was chosen by the Council and sworn in in December to fill the vacancy created by the resignation of Councilman Michael Hamilton. The seat now held by Ms. Hermelee will be filled for the remaining year of the term at the 2013 general election

Councilwoman Peggy Malkin was elected Council President, meaning that she will preside at Council meetings, and otherwise exercise the powers of the Mayor, in the Mayor's absence. She was also designated as Council's liaison with the Senior Citizens' Organization.

Councilman Ralph Warnick was chosen by the Council to be its representative on the Environmental Commission, as well as its liaison to the Board of Education. Councilman Ticktin was chosen as Council representative on the Planning Board and also as Roosevelt's member of the Monmouth County Community Development Block Grant committee, with Nancy Warnick being designated as his alternate.

The resolutions approved by the Council included authorization of renewal of shared services agreements with Millstone for the shared municipal court and for the repair and maintenance of Nurko Road, including snow removal there, and with Hightstown for repair and maintenance of water and sewer lines and municipal roads, as well as

for garbage collection. Councilman Warnick stated that Hightstown has increased its charge for garbage collection each year since the inter-local agreements began, but that the charges have averaged out to amounts that do not exceed the budget caps and are still considerably below what we formerly paid to private contractors.

The Council appointed the following committees, with the first named being the committee chairperson in each case:

Administration: Michael Ticktin, Jeff Ellentuck, Peggy Malkin

Utilities: Michelle Hermelee, Michael Ticktin, Jeff Ellentuck

Public Works: Tom Curry, Ralph Warnick, Peggy Malkin

Community Development: Jeff Ellentuck, Michelle Hermelee, Ralph Warnick

Environment, Health and Safety: Ralph Warnick, Tom Curry, Michael Ticktin

Finance: Peggy Malkin, Michelle Hermelee, Tom Curry

Mayor Beth Battel thanked Arlene Stinson for her years of service as a Council member and once again thanked all of the volunteers who serve the community, especially the emergency service volunteers. She appointed Stuart Kaufman, who is also chairman of the Environmental Commission, as the Class 2 (public official) member of the Planning Board and appointed Nancy Warnick, hitherto an alternate member,

Ben and Bernarda Shahn House Designated as “Unique Historic Resource”

The New Jersey Historic Trust, a State agency established for the purpose of preserving properties of historic, aesthetic, architectural and/or cultural significance, was given a conservation and preservation easement for the Ben and Bernarda Shahn House, located at 20 Tamara Drive, by the Shahn family, prior to the recent sale of the property to Chisa Yagi.

The deed establishing the easement, which was filed with the Monmouth County Clerk on October 16, 2012, describes the property as a “unique historic resource,” stating that the purpose of the easement is “to preserve the property and prevent any use...that is not historically appropriate, or that will significantly impair or interfere with the historic features.” It describes the house as a certified historic property representing a valuable example

of a Bauhaus-inspired residence with mid-twentieth century modernist additions, having associations with the designs of Alfred Kastner, Louis Kahn and George Nakashima and community design during the New Deal era, as well as with the artists Ben and Bernarda Shahn.


Alfred Kastner was the project architect for Jersey Homesteads and Louis Kahn, who later achieved worldwide prominence, and whose last design was for the FDR Four Freedoms Park that recently opened on Roosevelt Island in the East River in New York City, was his assistant. George Nakashima, who designed the addition to the Shahn House, was an architect, woodworker and furniture maker who was a leading innovator in furniture design.

The Borough of Roosevelt was placed on both the New Jersey and National Registers of Historic Places in 1983, and is the only municipality so designated in its entirety, but the Shahn house is the first individual structure to receive official historic designation. ■

Abdominal pain 6, Respiratory 18, Cardiac 20, Falls 28, Leg injuries 1, Altered Mental 2, Unresponsive 14, Seizures 8, Knee injuries 2, MVA 26, Fire stand-by's 25, Head injuries 6, Emergency transports 57, CPR 2, Back pain 1, Crisis 11, Medical alarms 2, Good & Welfare checks 5, Diabetic 2, Syncope 8, Burns 2, Overdose 1, Bleeding (Trauma) 2, Arm injuries 2, Haz-Mat 1, Rescue 1, Allergic reaction 1 (Epi-Pen was used)

The training for December was on patient care reports, bandaging and airway management. Training hours for the Squad 50.5 and total man hours 4,155.

Health Notes:

Respiratory Emergencies.

Respiratory emergencies are medical emergencies characterized by difficulty breathing or an inability to breathe at all. Such emergencies can become fatal if they are not addressed properly and promptly. If someone starts to show signs of respiratory distress, medical help should be obtained immediately. In the case of patients with chronic conditions which cause difficulty breathing, people should learn the difference between what is ordinary for the patient and what is a sign of a true emergency. For example, some people with asthma are naturally wheezy and it is not a cause for concern, while extremely labored breathing is a sign that the patient is in distress.

In a respiratory emergency, a patient may take frequent shallow breaths, irregular breaths, or very slow breaths. In some cases, the patient may even stop breathing. Respiratory emergencies are commonly accompanied by pale, cold, clammy skin, and the heart may stop beating or become irregular. The patient is also usually extremely agitated, which can add to the severity of the emergency because the patient will use more oxygen in a panic.

Heart failure, asthma, pneumonia, bronchitis, chronic pulmonary

obstruction disorder, croup, inflammation of the epiglottis, and the common cold are all conditions associated with respiratory emergencies. In patients with chronic conditions, medications may be used in an attempt to keep the airway open, and if the airway starts to close, prompt intervention may be needed. People can also experience acute reactions to allergens and drugs which lead to respiratory distress. And when objects become lodged in the throat, they can cause respiratory emergencies.

Some other causes of respiratory emergencies include medical problems such as pneumothorax, in which air fills the pleural space which surrounds the lungs, and pleural effusion, in which the pleural space becomes filled with fluid. Both of these conditions can happen as a result of trauma, and pleural effusion may occur as a consequence of long term chronic disease.

Patients usually notice when they experience respiratory emergencies. They may attempt to speak and often gesture to indicate that they are having trouble breathing. It can be very frightening to be unable to breathe, and people providing care should try to keep the patient as calm as possible by assuring that help is coming. Remaining in an agitated state can create complications for the patient. If a patient stops breathing altogether, rescue breathing should be initiated to reduce the risk of brain damage and increase the patient's chance of survival. Before administering rescue breaths, the airway should always be checked and swept for signs of objects which may be causing obstructions.

If you suspect a respiratory emergency, always call 9-1-1. Don't wait.

2012: A Look Back

You may have heard that 2012 was the hottest year on record for the 48 contiguous states of the United States. 2012's average temperature was 3.2 degrees above normal. The year also had the second most extreme weather events according to the National Oceanic and Atmospheric Administration (NOAA). Remember Sandy? Globally, 2012 was the 10th hottest year on record.

In Roosevelt, the average temperature for 2012 was 56.3 degrees (F). That's a full four degrees above normal. Every month except November was hotter than normal. The hottest day of the year was July 7 when the temperature topped out at 99.1 degrees. The coldest was January 16th, when the mercury dipped down to 12.7 degrees. Precipitation for 2012 was almost 7 inches below normal. Snowfall came in at 12.8 inches. That's almost 10 inches below normal.

December

December in Roosevelt was about 1.2 degrees (F) warmer than normal. The warmer temperatures brought about 200 fewer heating degree days than normal for the month. We had about an inch more precipitation than normal. Most of that came in the form of rain. Only 2.25 inches of snow fell.

February

February is historically the snowiest month of the year in our region. Typically, we see about 7.5 inches of snow for the month. The average temperature range is between the low twenties and low forties. This February is expected to very cold according to the *Old Farmers Almanac*. They also predict that precipitation will be well below normal, off by about two inches. Meanwhile, LongRangeWeather.com is also calling for cooler than normal temperatures. But not nearly as cold as the *Old Farmers Almanac*. LongRangeWeather.com also says we'll have less than normal precipitation. Again, they don't think it will be as dry as the *Old Farmers Almanac* does. NOAA's Climate Prediction Center indicates equal chances for above, normal or below normal temperatures and precipitation for February in our region.



Weather Word

Snow Eater – A term used to describe warm dry wind that blows over a snowy terrain and melts the snow. Usually used in the Rockies. ■

After dark . . .






This is a very tasty recipe which is nice for entertaining. A woman I used to work with gave me this recipe; I just remember her first name, Debbie. It became a favorite in our house and has been saved in my notebook of "tried and true" recipes. Enjoy.

Debbie's Veal Rollettes

Approx. 4 servings

1 1/2 lbs veal round steak	1/4 tsp pepper
2 cloves garlic, finely chopped	Mozzarella cheese slices
1 T grated Parmesan cheese	3 T olive oil
2 tsp chopped parsley	1/2 C melted butter or margarine
1 tsp salt	1/4 C water

Preheat oven to 300° F.

Mix together Parmesan cheese, parsley, garlic, and salt and pepper

Cut veal into pieces approx 4" x 3" and 1/2" thick.

Place slice of mozzarella cheese on each piece of veal.

Top mozzarella with 1 tsp of garlic mixture.

Roll up the veal to enclose the mixture and cheese and fasten with a tooth pick and/or string and set aside.

Heat the 3 tablespoons of olive oil in a skillet and slowly brown the rolled meat on all sides.

Place the browned rolled meat in an oiled casserole dish and pour over the meat a mixture of the melted butter (or margarine) and water. Cover the casserole dish and bake for about an hour or until meat is tender when pierced with a fork.

Remove toothpicks and string and serve.
